Cilji in kompetence:

Cilj predmeta je študente seznaniti s temeljnimi koncepti socialne zaščite in prava socialne varnosti, osnovnim poznanjem izbranih teorij politične filozofije in njihovih ključnih konceptov ter jim omogočiti kritično uporabo tako pridobljenega teoretičnega okvira za obravnavo sodobnih vprašanj na področju socialnega prava tako v nacionalnem kot tudi nadnacionalnem okolju. Študenti bodo pridobili sposobnost širokega in večplastnega pristopa k reševanju konkretnih in sodobnih vprašanj s tega področja.

Objectives and competences:

The aim of the course is to provide students with an overview of the basic concepts of social protection, and social security law, the basic knowledge of selected theories of political philosophy and their key concepts, and enable them to critically apply this theoretical framework to contemporary issues in the field social law and social policy, both in a national and supranational setting. The students will acquire the ability of taking a broad and multi-layered approach to solving concrete and contemporary issues in the field.

- Critical understanding of contemporary and multi-layered social law issues in a (supra)national setting
