

Signs and support will be on hand to guide you to the halls and conference rooms.


**Means of Public transport:** no parking is available at the venue, thus we recommend using public transportation, coming on foot or using a nearby car park.

- **Travelling by bus:** lines **13** and **20** stop directly at the Faculty of Law, the bus stop is called “**Zmajski most**” (next to the famous Dragon bridge); another option is to take **any city bus to the city center and walk towards the Faculty** – in this case, exit the bus at “Konzorcij” or “Pošta”. The Faculty is a 5-10min walk away.




