Cilji in kompetence:

Cilj predmeta je, da slušatelj pridobi poglobljeno znanje s področja diplomatskega in konzularnega prava, kot ene od pravnih podpanog mednarodnega prava. Za nadgradnjo teoretičnega znanja slušatelji preko analize relevantne judikature, predvsem Meddržavnega sodišča v Haagu, pridobijo vpogled v reševanje konkretnih vprašanj v praksi.

Objectives and competences:

The objective of the course is for the students to gain an in-depth knowledge of diplomatic and consular law, as one of the sub-branches of international law. To broaden the theoretical knowledge the students learn to analyse relevant case law, especially the case law of the International Court of Justice, and thus get an insight into solving concrete issues in practice.

Predvideni študijski rezultati:

Znanje in razumevanje:
Po opravljenih obveznostih bo študent sposoben izkazati poznavanje mednarodopravne ureditve diplomatskih in konzularnih odnosov ter osnovne spretnosti in večine diplomatskega dela. Študent bo sposoben posamezne diplomatske in konzularne institute ustrezno razlagati ter jih pri praktičnem delu tudi korektno uporabljati. Študent bo pridobil predvsem sposobnosti ustnega in pisnega izražanja o pravnih vprašanjih, sposobnost pravniškega sklepanja, izdelave enostavnejših pravnih mnenj, in uporabe znanja v konkretnih primerih v praksi. Pridobljeno znanje je mogoče neposredno uporabiti pri delu v Ministrstvu za zunane

Intended learning outcomes:

Knowledge and understanding:
After finishing the course, the student will be able to show an understanding of the international legal regulation of diplomatic and consular relations and the basic skills for diplomatic work. The student will be capable of interpreting specific diplomatic and consular law institutes and using them in practical work. More specifically, the student will gain the skills of both oral and written legal expression of law issues, the skill of legal reasoning, preparation of simple legal opinions and learn to use the knowledge in practical cases.

The student will be able to directly apply the knowledge while working for the Ministry of Foreign Affairs and the diplomatic-consular
