Cilji in kompetence:

Študent naj pridobi temeljne in povezane ter analitično presejane informacije ter znanje o delovanju reguliranih trgov, zlasti s strani institucij EU in v državah članicah, posebej v RS, o razlogih za regulacijo teh trgov, delovanju ex ante in ex post, orodjih za njihovo delovanje, pravnih institutih, sistemih in institucijah nadzora, odstopu od klasične ureditve trga, razmerjih med regulatorjem / nadzornikom in organi, pristojnimi za varstvo konkurence, substančnih in postopkovnih posebnostih. Predmet študenta opremi s temeljnim deskriptivnim znanjem in analitskimi mehanizmi in sposobnostmi. Študent mora osvojiti vrsto izbranih tem in področij.

Objectives and competences:

The student should acquire basic and related information, as well as analytically sophisticated information and knowledge about the functioning of regulated markets, in particular those which are regulated by EU institutions and in the Member States. The reasons for regulating these markets, the operation of ex ante and ex post, the tools for their functioning, legal institutes, systems and supervisory institutions, deviation from the classical market organization, relationships between the regulator / supervisor and the authorities responsible for the protection of competition, subsidiary and procedural specificities shall be analysed. The course gives the student basic descriptive knowledge, analytical mechanisms and abilities. The student must master a series of selected topics and areas.

Predvideni študijski rezultati:

Intended learning outcomes:

Znanje in razumevanje:

Študent pridobi osnovno znanje o delovanju reguliranih trgov, zlasti s strani institucij EU, razlogih za njihovo regulacijo, orodjih za njihovo delovanje, pravnih institutih, sistemih in institucijah nadzora, odstopu od klasične ureditve trga, razmerjih med regulatorjem / nadzornikom in organi, pristojnimi za varstvo konkurence, substančnih in postopkovnih posebnostih. Predmet študenta opremi s temeljnim deskriptivnim znanjem in analitskimi mehanizmi in sposobnostmi. Študent osvoji vrsto izbranih tem in področij. Pridobljeno pravno znanje je neposredno uporabno, saj mora pravnik pri svojem delu poznati gospodarsko okolje. Pravno znanje je neposredno uporabno, ker so temeljno in analitično obdelani instituti in vsebinski sklopi, ki so nujen instrumentarij za uporabo v praksi, omogoča pa tudi nadgradnjo na II. stopnji študija. Pridobljeno znanje omogoča presojo posledic ravnanj gospodarskih subjektov, fizičnih oseb in drugih udeležencev v ekonomskem in pravnem prometu v gospodarskem okolju in pravni ureditvi ter gospodarskem ter pravnem sistemu. Pridobljeno znanje zagotavlja osnovo za razumevanje drugih predmetov s področja gospodarskega prava. Predmet je nadgradnja predmetov Gospodarsko pravo, Pravo EU, Korporacijsko pravo, Bančništvo, zavarovalništvo ter finančni trgi.

Knowledge and Understanding:

The student acquires basic knowledge about the functioning of regulated markets, in particular in the EU, the reasons for regulation, the tools for their operation, legal institutes, systems and supervising institutions, deviation from the classical market organization, relations between the regulator / supervisor and the bodies responsible for protection competition, substandard and procedural specificities. The course enables the student to acquire basic descriptive knowledge and analytical mechanisms and abilities. The student shall master a number of selected topics and areas. The acquired legal knowledge is directly applicable, as the lawyer ought to know the economic environment in his work. Legal knowledge is directly applicable because the student masters the institutes and contents through analytical approach. The course allows upgrading to the second cycle of the study programme. The acquired knowledge enables the assessment of the consequences of the conduct of economic operators, natural persons and other participants in economic and legal traffic in the economic environment and in the legal system and the economic and legal system. The acquired knowledge provides a basis for understanding other courses in the area of commercial law. The course upgrades the courses in Economic Law, EU Law, Corporate Law, Banking, Insurance and Financial Markets.
