11. Professional experiences:

Marko Simoneti has extensive professional experience in economic transition in Slovenia as well as in Central and Eastern Europe since the very beginning of the process in 1989.

As Undersecretary of State in the Federal Government (1989), he served as adviser for economic reforms and took part in drafting the first privatization legislation and designing the key government institutions responsible for privatization in former Yugoslavia.

As the first Managing Director of the Agency for Privatization, Slovenia (1990-1993), he was responsible for its institutional development and day-to-day management. He led the expert groups preparing guidelines for different methods of privatization and organizing business valuation system in Slovenia. He led or participated in the first largest privatization transactions with foreign buyers in Slovenia. He took part in the project of restructuring of 100 loss-making enterprises, carried out by the Development Fund of Slovenia.

He was among the founders of the Central and Eastern European Privatization Network (CEEPN)- the first international intergovernmental organization in the new independent state of Slovenia, the first Chairman of its Steering Committee (1991-1992) and its long term Executive Director (1993-2004). He served as coordinator of CEEP annual conferences, workshops and training seminars. He served as private sector development adviser to various international organizations (The World Bank, EBRD, OECD, UNDP, UN-ECE). He took part in several country missions of the World Bank to render advice on financial and enterprise sector development and contributed to drafting of programs financially supported by the World Bank (Hungary, Georgia, Iran, Russia, Latvia, Poland, Bosnia, Serbia, Montenegro, Macedonia; Egypt). He was leading international projects providing policy advice in Slovenia in post-privatization period: long-term financing of privatized enterprises (EBRD), regulation of privatization funds (EU-PHARE) and state aid monitoring system (EU).

He took an active part in drafting the first law on investment funds and securities markets in Slovenia. He served as the Vice-chairman of the first Board of the Securities and Exchange Commission in Slovenia, Member of the Supervisory Board of Ljubljana Stock Exchange (1998-2004), President of the Supervisory Board of the asset management company MedvešekPušnik (2003-2004) and Chairman of the Government Commission for privatization of NLB - the largest bank in Slovenia (2001-2002). During the management crisis at Ljubljana Stock Exchange in 2004, he was appointed for a five year mandate as the President of the Management Board. Later he was elected by representatives of the European stock exchanges for a member of the Board of FESE – the Federation of European Securities Exchanges. He was a member of the Government Strategic Economic Council (2005-2006)

with responsibility for privatization and financial sector development program. After the financial crisis, from November 2009 to summer 2012 he served as the President of the Supervisory Board of the largest bank in Slovenia (NLB) and from October 2015 to January 2017 as the Chairman of the "bad bank" of Slovenia (BAMC).

He holds the position of associate professor at The Faculty of Law and he has lectured for 20 years on financial institutions, corporate finance and public finance in the undergraduate and graduate courses in Slovenia and abroad (WU Executive Academy in Vienna, MBA program in Macedonia). He has published numerous articles in professional and academic journals and edited several books on problems of economic transition and financial sector development.
